ANITA ANDREW is a China Specialist (PhD University of Minnesota) at Northern Illinois University in DeKalb, Illinois. Her research and teaching interests include the social control efforts of the founding emperor of the Ming Dynasty, Zhu Yuanzhang (reigned 1368–1398 CE); the history of intercountry adoption of Chinese children in America since the 1990s; and the history of Chinese influences in America. Her publications include *Chinese Studies in History* (Armonk: ME Sharpe, 2000); *Autocracy and Rebel Founding Emperors: Comparing Ming Taizu and Chairman Mao* (Armonk: Rowman & Littlefield, 2000); “Contemporary Issues” from *China (Asia in Focus)*, ed. ROBERT ANDRÉ LAFLEUR is an anthropologist and historian who focuses on the intersection of text and culture in Chinese life. His publications include *China: Global Studies* (Santa Barbara: ABC-Clio, 2003) and a substantially revised second edition in 2010. He received his PhD from the University of Chicago's Committee on Social Thought and is Professor of History and Anthropology at Beloit College. He has spent the past year giving a lecture series at Beijing University and completing a research fellowship at the Internationales Kolleg für Geisteswissenschaftliche Forschung in Erlangen, Germany, where he has studied divination practices on China's sacred mountains.
